



Youth Volunteer Liability Release Form



Legal guardians must sign for any minor, individuals under 18 years of age, participating in a joint NSEA & Parks Volunteer Activity. This form must accompany the participant to the joint NSEA & Bellingham Parks work party and be given to the event coordinator.

I/We will not hold the City of Bellingham, its agents, employees and volunteers, or anyone otherwise involved in City of Bellingham Parks' programs for which I am participating responsible for any accident or injury that might occur, negligence notwithstanding. I therefore hold the City of Bellingham and their respective agents harmless and release and waive all claims against the City of Bellingham that arise from my/our volunteer activities.

Further, I/we acknowledge that we are undertaking this activity voluntarily, assume all risks associated with this volunteer activity, and agree that I/we will not perform any work we are not qualified to perform.

In the event of injury or illness of a minor, I understand that reasonable effort will be made to contact the parent immediately. However, I am aware that if the injury or illness appears serious and the parent cannot be reached, the adult in charge will secure emergency medical care as needed.

Further, I/we realize no insurance coverage is provided for the participant and will assume financial responsibility for any cost relating to any accident or injury that might occur while participating in above named program.

I understand that minors under 16 years old must also be accompanied by an adult.

I/We grant permission to the City of Bellingham and its sponsors to use photographs, motion pictures, personal data, recordings or any other record of this event for legitimate purposes.

I/We As a volunteer for the Nooksack Salmon Enhancement Association the undersigned have read and agreed to the following Release, Hold Harmless and Indemnity Agreement:

Nooksack Salmon Enhancement Association, its employees, officers and agents shall not be liable for any injury, including death, damages or liability, to any persons and/or agencies for damage to property regardless of how such injury or damages, caused, sustained or alleged to have been sustained by the volunteer or by others as a result of any coordination or occurrence whatsoever related to this project. Nooksack Salmon Enhancement Association has volunteer L&I for any injury occurring during the course of this work.

However, the organization will not be responsible for the loss of wages as a result. It is, therefore, the volunteer's responsibility to report any injuries promptly to the project coordinator. If, in fact, a volunteer causes an injury to another volunteer, Nooksack Salmon Enhancement Association will not be responsible for the conduct of that volunteer or injury of the volunteer who was injured.

Nooksack Salmon Enhancement Association has the right to take photographs or video of the volunteer participating in this event, and use of resulting photographs/video for any lawful purpose, including publicity, advertising, illustration and website content. The personal information collected allows Nooksack Salmon Enhancement Association to provide announcements, updates, and upcoming events to volunteers. It also helps improve services, content, and advertising. All info may be shared with community partners during shared events. The volunteer agrees that this release, hold harmless and indemnity agreement, including any digitally saved copies, shall be binding on this date.
